Gamma Intermediate S.à r.l. completa la vendita di azioni di Lottomatica

- Vendita di 15 milioni di azioni di Lottomatica rappresentanti circa il 6% del capitale sociale di Lottomatica mediante un'offerta tramite accelerated bookbuilding;
- Corrispettivo complessivo lordo di circa €166,5 milioni, per Gamma Intermediate, dal collocamento;
- Gamma Intermediate S.à r.l. mantiene una partecipazione pari a circa il 51,5% del capitale sociale di Lottomatica.

Gamma Intermediate ha completato il collocamento di **15 milioni** di azioni di Lottomatica (le "**Azioni**"), rappresentanti circa il **6**% del capitale sociale di Lottomatica, attraverso un collocamento privato (*private placement*) mediante un'offerta tramite *accelerated bookbuilding* (il "**Collocamento**"). Il prezzo di vendita del Collocamento determinato nel contesto dell'offerta, tramite *accelerated bookbuilding*, rivolta agli investitori istituzionali è stato fissato ad **€11,10 per Azione**, con il *settlement* previsto per il giorno 24 settembre 2024 o intorno a tale data.

Gamma Intermediate manterrà una partecipazione pari al **51,5**% del capitale sociale di Lottomatica dopo il completamento del Collocamento.

Gamma Intermediate ha accettato un *lock-up* di 90 giorni per le proprie rimanenti Azioni di Lottomatica, subordinatamente al *waiver* da parte dei *Joint Global Coordinators* (come sotto definiti) e ad alcune altre deroghe consuete.

Barclays Bank PLC ("Barclays") e Deutsche Bank AG ("Deutsche Bank") agiscono nel ruolo di *Joint Global Coordinators* e *Joint Bookrunners* (assieme, i "Joint Global Coordinators" o i "Managers") e Latham & Watkins agisce come *advisor* legale del Venditore.
